Multi-family, commercial and industrial properties that fail to certify compliance by October 31, 2010 will be subject to a surcharge of 25% on their water bill for 12 months. At any time during those 12 months, you may install the required measures and submit the Certificate of Compliance form. Upon receipt of the form the surcharge will be discontinued.
