BWP COMMERCIAL LANDSCAPE BATTERY REBATE TERMS AND CONDITIONS

- Applicant must have participated in the South Coast AQMD Commercial Electric Lawn and Garden Program.
- Rebate requests must be submitted to BWP no later than FOUR MONTHS from the date of purchase.
- Applicant must be a commercial BWP customer with an active BWP electrical account.
- BWP's rebate applies to the purchase of a new battery for electric lawn and garden equipment only. Rebate is for a maximum amount of \$500, up to 50% of the total cost of the extra battery.
- Application must be signed, dated, and contain all of the supporting documentation.
- A rebate check will be mailed to the applicant within 6-8 weeks of BWP receiving the application and supporting documentation.
- Rebates are not guaranteed and some limitations apply.
- Rebate program is subject to change without notice.
- BWP is not responsible for items lost or destroyed in the mail.
