| <p>Terms and Conditions</p> <ul style="list-style-type: none"> Applicant must be a BWP customer with an active BWP electrical account or charge their electric vehicle (EV) at a location with an active BWP electrical account. This application must be signed, dated, and contain ALL supporting documentation. Residential customers will be placed on the TOU electric rate in order to receive the EV Charger rebate. BWP is not responsible for items lost or destroyed in the mail. Rebates are not guaranteed and some limitations apply. Applications must be submitted no later than FOUR months from the date of purchase and are accepted on a first-come, first serve basis. A rebate check will be mailed within 6-8 weeks of BWP receiving the application. Rebates are limited to one (1) rebate per residential account, and four (4) rebates per multi-family house account or commercial account per fiscal year. If applicable, the applicant must have approval from the property manager, owner, or homeowners' association to install the charger. Charger(s) must be Level 2 (240V) and utilize the SAE J1772 charging plug or Tesla's High Power Wall Connector and be UL or equivalent listed. Chargers with greater capacity will be considered on a case-by-case-basis. Charger(s) must be a new purchase with installation hardwired to the property's electrical service and have a City of Burbank Building Division permit issued. The EV must be DOT approved for highway application.
