Step 3: To Submit Your Refrigerator Exchange Program Application

Please submit the following documents to the Burbank Temporary Aid Center (BTAC) at 1304 W. Burbank Blvd.

- □ A copy of your most recent BWP bill
- \Box A valid ID must be provided for all members living in the household
- □ A copy of your checking and savings bank statements for the last 2 months
- \Box A copy of your current payroll stub and previous year's income tax return
- Documentation of other financial assistance you may receive
 (i.e. Section 8, SSI, Unemployment Statement Letter, etc.)

BWP Lifeline Customers Need Only Provide:

- □ A copy of your most recent BWP bill
- □ A valid ID must be provided for all members living in the household
- If your current refrigerator has an ice maker or water line attached it must be disconnected prior to your appointment date. If the ice maker or water line is not disconnected it will result in a delivery delay of your new refrigerator.

Supplemental Application for a Leased Refrigerator
